The Chinese Model of Infrastructure Development in Africa By Uzor Ezechukwu

The volume of Chinese Official Development Assistance (ODA) channeled into infrastructure development in Africa has grown sharply in recent years, compared to other donors like the Organisation for Economic Co-operation and Development (OECD) countries. To finance infrastructure projects in Africa, China's policy banks use financial instruments that link Africa's natural resources and agricultural raw materials to its development. This paper examines infrastructural development as a key step in providing a competitive business environment for African economies.

Members of international development and research communities from Africa, Asia, Europe, Latin America and North America convened to discuss various issues centered around the core themes of the conference which includes: shaping of the international development agenda for post-2015 period; identification of implementation challenges of the post-2015 agenda and understanding national implications for implementing post-2015 international development goals. The conference also provided a platform for Southern Voice research grantees to present their papers and invite inputs form other participants. Dr. Ebere Uneze presented a paper titled 'Exploring Domestic Financing Options for Post-2015 Development Agenda in Selected Sub-Saharan African Countries'.

"Participants explored various perspectives and shared knowledge and experience on how research quality can lead to think tank impact and how think tanks can ensure quality research while maintaining policy relevance.



Financing the Sustainable Development Goals International Conference March 17-18, 2015 Accra, Ghana

Given the changing nature of development finance in the international sphere, the <u>Sustainable</u> <u>Development Goals International Conference</u> was put together in order to shape the global priorities for economic, environmental and social development to meet the challenges of a new era. The conference was organised by the Overseas Development Institute (ODI) and a global coalition of partners, including United Nations Development Program (UNDP), Development Finance International (DFI), Economic and Social Research Foundation (ESRF), African Center for Economic Transformation (ACET) and Development Initiatives (DI). The theme of the conference 'Financing the Future: Fresh Perspectives on Global Development' explored how international public finance can best contribute to accelerating progress in development from 2015. Dr. Ebere Uneze joined other high-level speakers from around the world to discuss and identify core issues of financing for development.

"Managing Capital Flows"

The report presented the view of the International Monetary Fund (IMF) on capital flows and its implication for macroeconomic management. The paper also addresses issues including: the importance, structure, size and composition of international capital flows and the spill-over effects; the relationship between international capital flow and domestic macroeconomic management and what should be the reaction of the monetary authority to managing international capital flows risks.

presented by Dr. Emmanuel Nwosu, Department of Economics, University of Nigeria, Nsukka March 11, 2015

The <u>report</u> highlighted the major factors impeding the growth of women-owned businesses in developing countries which includes low access to formal credit for small and medium enterprises in Nigeria. It also investigates the impact of credit access on the performance of enterprises.
